### Types of Membership:

- Individual Membership:** Open to all persons 18 years and older. **\$25.00**
- Family Membership :** Open to any two related or unrelated adults living at the same address in Canada and any minor children, residing with them.. Youths under 18 years of age are not eligible to vote or to hold office as an Officer or Director. Only one copy of each issue of the Club Newsletter will be sent per Family Membership. **\$25.00**
- Associate Membership:** Open to all persons, sponsored by an Irish Setter Breeder who is a Club Member in good standing, on receipt of an Irish Setter puppy. This membership is valid for the remainder of the Club year, and is renewable as a full membership. Associate members do not have the right to vote on Club related matters nor to hold office In the Club. **\$10.00**
- Residents of Countries outside Canada** who apply for membership may only be Associate Members, by Canadian Kennel Club (CKC) regulations. Associate members are not eligible to vote on Club matters nor hold office, as per CKC Rules. **\$25.00 US.**

Membership in the Club is contingent on having read and agreed to abide by the Club Principles of Integrity that are found **on the website**. We would encourage you to also review the Club constitution found **on the website**.
